Requests for telephone bidding generally will be honored if we are contacted at least 24 hours prior to the auction start time. Please plan to bid in the increment multiples shown on this page. Otherwise, bids will be rounded down to the nearest increment. In the event of identical bids, the earliest received will take precedence. Stanford Auctioneers will strive to execute your bids on your behalf but will not be liable for errors or omitted bids.

**FIRST-TIME BIDDERS:** If you this is your first time bidding with Stanford Auctioneers, we may require the following information:

- Copy of credit card in your name
- Copy of recent utility bill or current driver's license

You may be asked to provide further financial account information to secure your bidding account.

**TELEPHONE BIDDERS:** The lot(s) must have a low **estimate** of at least \$100 to be eligible for telephone bidding. If a member of our staff should accept your telephone bid request for a lot that does not meet this criteria, this is not a guarantee of service. A limited number of telephones are available.

**Bid increments:**

\$0 - 100	\$10 increments
\$100 - 500	\$25 increments
\$500 - 1,000	\$50 increments
\$1,000 - 2,500	\$100 increments
\$2,500 - 5,000	\$250 increments
\$5,000 - 10,000	\$500 increments
\$10,000+	\$1,000 increments

The auctioneer may use his/her discretion to split the bid at any time.
